Upon further review of your application for a Non-Conforming Use Certificate to continue Transient Vacation Rental operations, the Planning Department conducted a routine field inspection of the subject property on August 3, 2011 and found the following violations of the zoning code:

Article 19. Zoning permits Sec.8-19.1 When Required. No person shall undertake any construction or devolpment or carry on any activity or use, for which a zoning permit is required by this Chapter, or obtain a building permit for construction, devolpment, activity or use regulated by this Chapter, without first obtaining the required zoning permit.

The portion of 2nd floor Lāna'i along with associated construction of an exterior partition wall with screen without the proper permits constitutes a violation.

Pursuant to Chapter 8, Kauai County Code, you are directed to comply with the following requirements immediately:

- a. Submit plans and applications for the portion of 2nd floor_Lāna'i along with associated construction of an exterior partition wall with screen along with filing fees for review.
- b. All Additions and Construction not provided and approved by the Planning Department shall removed.

Failure to contact the Planning Department in **writing** within <u>15</u> calendar days upon receipt of this letter to provide an acceptable plan for compliance provides us with no other alternative but to issue a Notice of Violation and pursue litigation. Please call me at (808) 241-4050.

Batty (hereinafter "Batty") signed on March 11, 2009, that was submitted as part of TVNC #1023 verifying that Lihi Kai has been operating as a transient vacation rental since 1981 and that Batty has paid GET and TAT taxes under GET license number W40387786-01.
- 5. Lihi Kai was built in 1982, but the Building Division's website does not list any building permit for the original house.
