**SUBJECT: CERTIFICATION OF RESULTS**

The Office of the County Clerk, County of Maui, would like to inform you that the petition submitted by your committee to propose an ordinance entitled "A BILL PLACING A MORATORIUM ON THE CULTIVATION OF GENETICALLY ENGINEERED ORGANISMS" does not contain the required amount of valid signatures as set forth in Section 11-3(2), Charter of the County of Maui. As noted in the attached certificate, you are 3,745 signatures short of the required amount.

Pursuant to Section 11-5, Charter of the County of Maui, your committee has twenty days after the receipt of this notification to file a supplemental petition. Our office will then have ten days to review the supplemental petition, should your committee submit a supplemental petition within the time frame allotted.

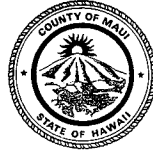
The procedures for collecting signatures for the supplemental petition are the same as for the original petition, excluding the submission and review deadlines.

**CERTIFICATE OF RESULTS**

I hereby certify that the following is a true and correct tabulation of the result of my office's examination of the petition submitted by the SHAKA Movement proposing an ordinance by initiative power, entitled "A BILL PLACING A MORATORIUM ON THE CULTIVATION OF GENETICALLY ENGINEERED ORGANISMS", which was deemed filed on April 7, 2014. The petition is insufficient under the County of Maui Charter § 11-3(2), as it is signed by less than the required number of qualified voters of the County.

Pursuant to § 11-4(2) of the Charter of the County of Maui, the following findings show the particulars wherein the petition is defective.

Under the County of Maui Charter § 11-3(2), the petition must be signed by not less than 20 percent of the total number of voters who cast ballots in the last mayoral general election. 42,322 total votes were cast in the last mayoral general election. 20 percent of 42,322 equals 8,464.4, which represents the total number of signatures needed for sufficiency. Thus, 8,465 valid signatures are needed to meet the requirements in the County of Maui Charter § 11-3(2).
